RE: Road Right of Ways

At the recent annual meeting, the following was approved unanimously:

1. NO dumping of garbage or large rocks is allowed in a road right-of-way.
2. NO plowing or growing of crops is allowed in a road right-of-way.

The road right-of-way is 4 rods wide (66 ft.) on any township road.

Any violators will receive a 10-day notice to correct the violation. If it is necessary, the Township Board will contract to have the matter corrected and bill the owner on his taxes.

NOTICE OF OPEN BURNING

PROPERTIES WITHIN THE CITY OF WATERVILLE

EFFECTIVE DATES: May 1, 2018 to June 1, 2018

DAILY HOURS: 8:00 a.m. TO 8:00 p.m.

Open burning as allowed and specified in MN Rule 7005.0705 to 7005.0805, MS 88.16. MN Uniform fire code and local ordinances.

FIRE SAFETY AND AIR QUALITY REQUIREMENTS

- To keep this fire under control and to assume responsibility for all that may result from burning done under this permit.
- To attend this fire until completely extinguished.
- Not to burn if there is a practical alternative method for disposal of materials.
- To use a clean burning device to start the fire.
- Not to conduct burning during an air quality alert.
- Not to burn paper, cardboard, treated wood, construction lumber except as provided under MN Statutes 17.135.
- That prevailing wind must be away from nearby occupied buildings.
- That fires will not be allowed to smolder or create excess smoke without flame.

PROHIBITED MATERIALS ARE: Oils, rubber, plastics, tires and chemically treated materials such as railroad ties, treated lumber, shingles, tar insulation, composite board, sheet rock, wiring, paint, hazardous and industrial waste and furniture of any kind.

Violators of the stated conditions may be subject to criminal actions.
